**THE EAST SUSSEX (PUBLIC FOOTPATH KINGSTON NEAR LEWES 21  
DEFINITIVE MAP MODIFICATION ORDER 2021**

TO:- Statutory Consultees

The above Order, made on 24 September 2021, if confirmed as made, will modify the Definitive Map and Statement for the area by:

A route comprising a public footpath starting at the public highway known as Ashcombe Lane TQ 39230844. The route runs in a north-easterly direction across properties Audiburn for 17 metres, Meadow Way for 31 metres then again across Audiburn for 85 metres then Castelmer Fruit Farm for 116 metres before turning in a east-north-easterly direction for 114 metres then running again across Audiburn for 100 metres until it reaches public footpath Lewes 37 at the parish boundary TQ 39600872.

The width of the public footpath along its length is 2 metres.

Applicants are requested to state the grounds on which it is made.

If no representations or objections are duly made to the Order, or if any so made are withdrawn, the East Sussex County Council, instead of submitting the Order to the Secretary of State may itself confirm the Order. If the Order is submitted to the Secretary of State for the Environment, any representations or objections which have been duly made and not withdrawn will be sent with it.
