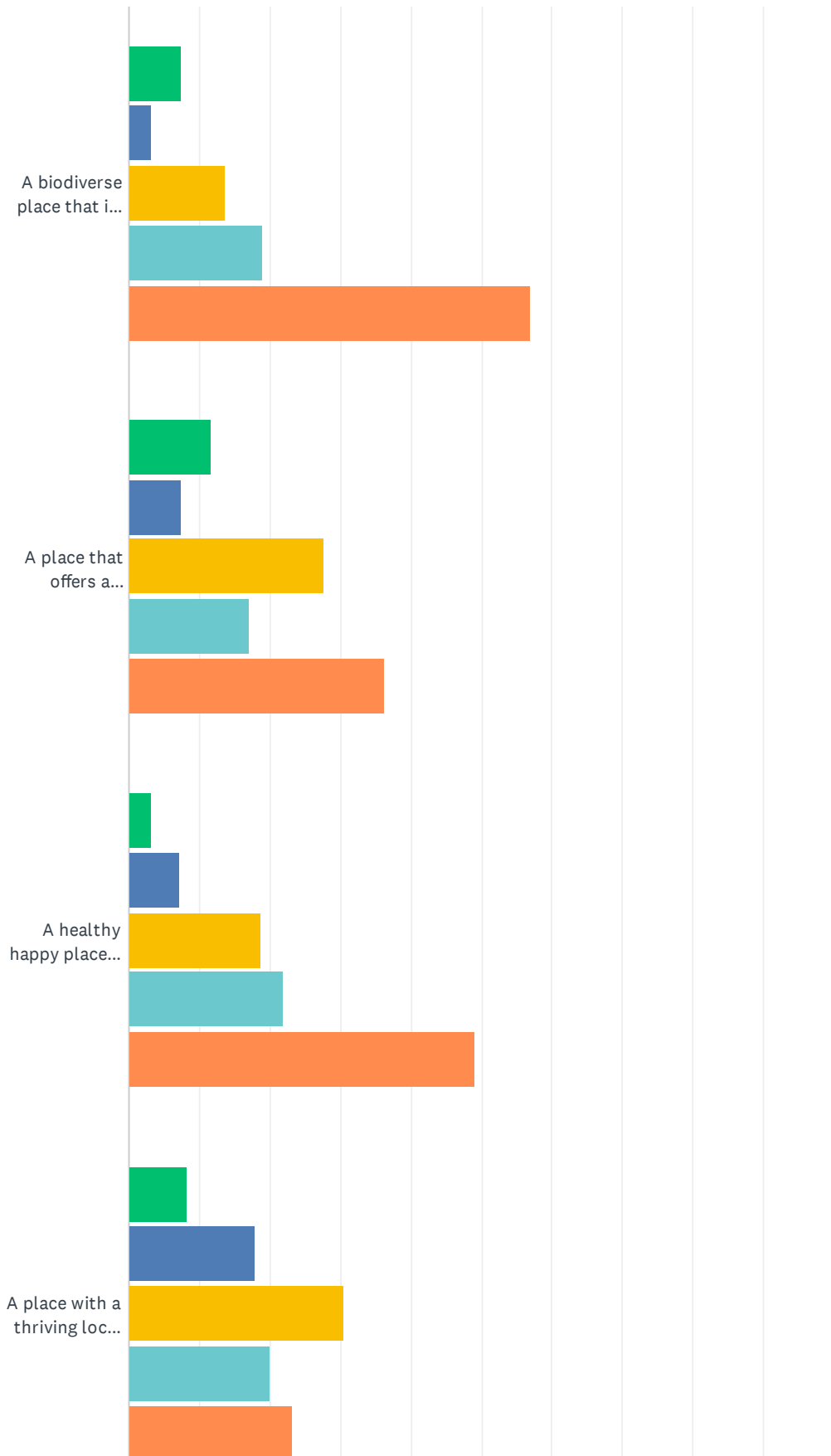
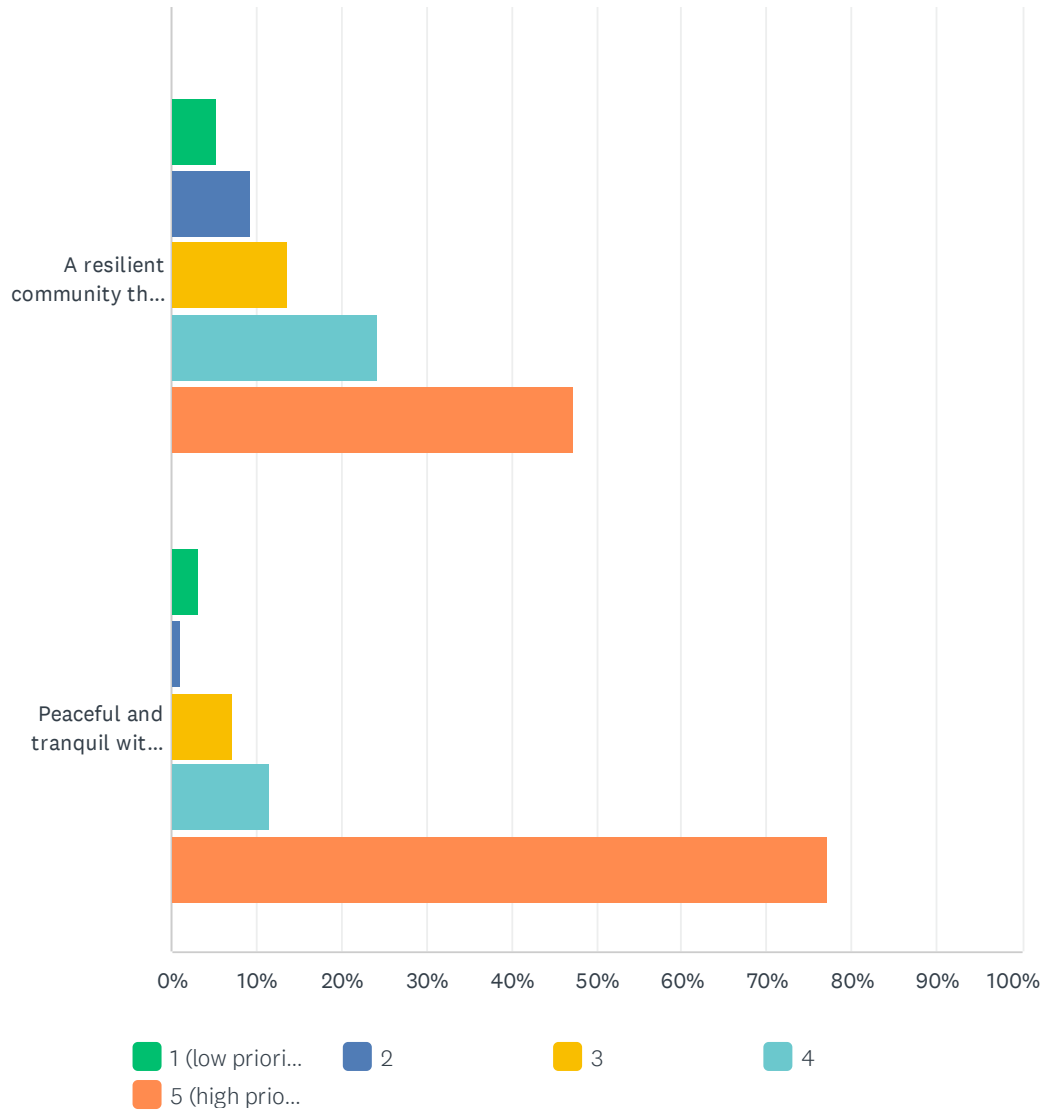


Q1 Please indicate how strongly you would prioritise the following visions for Kingston for the next 15 years:

Any traffic solution which improves the 2-way flow of traffic outside the school at school times (with the side effect of preventing dangerous parking next to the school) should be an improvement. I'm no expert but surely a traffic modelling specialist could suggest something to help? We have enough community buildings & they are already underused. By all mean repurpose one for different uses but we don't need more! It's been really pleasing to have Ashcombe Hollow resurfaced - it's made a big difference to traffic safety on that stretch of road. I am unclear what is meant by 'health' services for the community. More information needed please. I much prefer Solar & hydro energy schemes to wind turbines as the wind turbine blades endanger wildlife. Anything to improve broadband signal would be welcome: we have to be realistic about the future of technology.

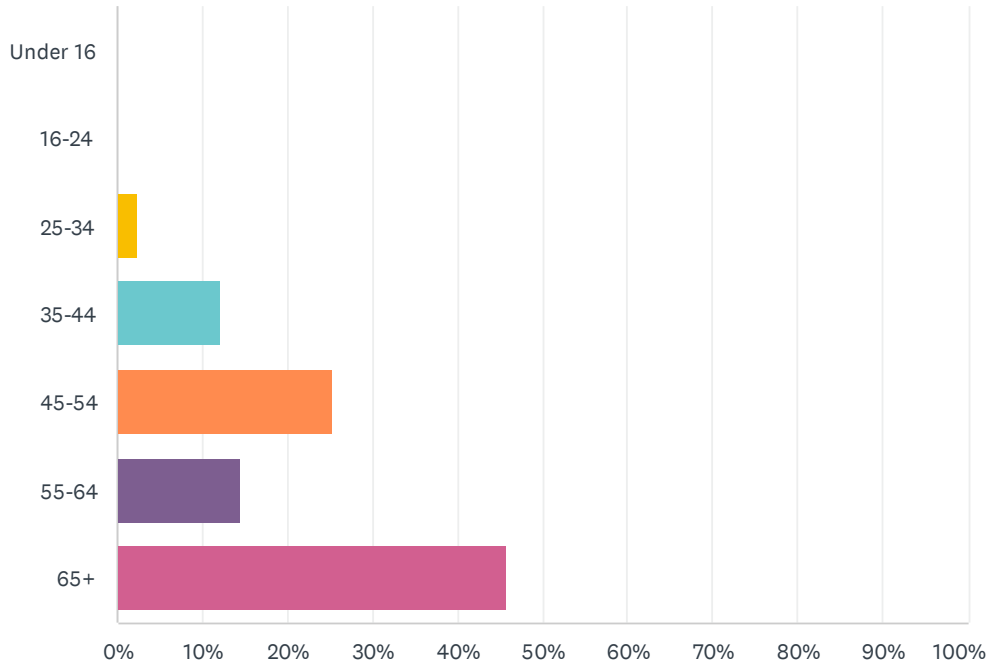
